Clerk has not yet submitted replacements yet as further discussion is needed with regards to what can be done, there are now two damaged posts. Both notice boards are now with the contractor and awaiting installation. Finger posts update
12/04/22	Village Hall Report from Cllr Fallon Mr Paul Ray has now stepped down as Chairman and Mr David Coton is now the new Chairman, Secretary is Lesley Sratt and the Letting Secretary is Julia Moore. At the moment they are looking for a Treasurer. At the present time the Village Hall are looking at getting the refurbishment of the kitchen completed, redecorating the toilets and main hall. It is hoped that they will be able to apply for a Jubilee grant to refurbish the garden. One grant available is the Community Chest Grant from SCDC, with the group are aware of.

D P Gardens have agreed to carry on for one more year but they have to increase their charges due to the sudden rise in fuel costs. The cost of one year is £11,330.00 and would be in increase of £222.50 per month.

- There has been a report of grafitti under the underpass near Melbourn, is it possible to do a joint project with Melbourn Parish Council. This was once done with MAYD and CCC but nothing since then.
- CCC verge cutting. In 2021 CCC adopted a new verge management policy. As part of the development of this policy CCC worked with the organization Plantlife. Plantlife are running the No Mow Way campaign and Cambridgeshire Highways are supporting the campaign and they will not be cutting any highway verges during the month of May.
